Issued under Section 35(4) of the National Heritage Resources Act, Act No. 25 of 1999. Permission is hereby given:

to: Dr J Neveling,

of: the Council for Geoscience, Private Bag X112, Pretoria, 0001,

for: geological hazard investigations which include a shallow drilling programme for neotectonic investigation (22 borehole positions proposed for drilling) and Shear wave velocity measurements which include Passive Seismic Measurements, Active Seismic Measurements and P-S Seismic Suspension (or down hole) Measurements,

at: Thuyspunt, between Oyster Bay and Cape St Francis,

in: the Koega District, Eastern Cape Province.

The following conditions apply:

- 1. A qualified professional archaeologist must be on site at all times to monitor all activities related to this permit. Should specifications for the proposed work need to change on site, this should be done in consultation with the archaeologist and the SAHRA APM Unit, must be informed prior to any further work commencing. SAHRA must be provided with the name, and if necessary qualifications, of the archaeologist employed for the project.
- 2. If the permit holder is not to be present on the site at all times then SAHRA must be provided with the names and qualifications of the authorised representatives.
- 3. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be used.
- 4. All material collected during the drilling process must be assessed by an archeologist and any archaeological material, as well as field notes and records, will be curated by the Albany Museum.
- 5. A report must be submitted to SAHRA on or before 01 June 2012. SAHRA reserves the right to withhold further permits if progress is not deemed satisfactory.
- 6. Reprints of all published papers, or copies of theses or reports resulting from this work must be lodged with SAHRA.
- 7. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
- 8. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
- 9. It is the responsibility of the permit holder to fill in the boreholes once drilling is complete and to protect sites during and after excavation to the satisfaction of SAHRA and the landowner
- 10. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
- 11. SAHRA reserves the right to cancel this permit by notice to the permit holder.
