TEMPORARY EXPORT PERMIT

Issued under Sections 32 and 35(4) of the National Heritage Resources Act, Act No. 25 of 1999. Permission is hereby given:

to: Dr R Smith (ID: 5101025066102),

of: Iziko South African Museum, P O Box 61, Cape Town, 8000,

for: the temporary export of a Triachodon skull with articulated lowerjaw (previously numbered 12168, accession number SAM-PK-K5821), a fully prepared skull with lower jaw with characters consistent with Hoffmeyriidae (accession number SAM-PK-K6731) and a small skull with lower jaw incissors and postcanines from the genus Therocephalian (accession number SAM-PK-K8611),

from: Paleontology Export 226, Cape Town, Western Cape Province,

to: Dr C Kammerer,

of: Department of Vertebrae Palaeontology, African Museum of National History, Central Park West at 79th Street, New York, NY 10024-5192, USA,

for: non-destructive CT scanning and morphological study.

The following conditions apply:

- 1. The objects or specimens must be clearly marked with accession numbers.
- 2. The material must be carefully packed and all packaging must be clearly marked with the accession numbers, the name of the site, and the name and address of the permit holder or the Iziko South African Museum.
- 3. The material must be hand carried or sent via a reputable professional courier service unless written instructions to the contrary have been received from the repository, Iziko South African Museum.
- 4. The material may not be loaned to any person or institution other than Dr C Kammerer without the consent of SAHRA.
- 5. The material shall be returned to South Africa on or before 01 March 2011 at the expense of Dr C Kammerer.
- 6. SAHRA must be notified in writing of the return of the material, and a report on the activities undertaken in terms of this permit must be lodged with SAHRA before 01 March 2011.
- 7. Copies of all papers or publications resulting from this permit must be lodged with SAHRA.
- 8. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
- 9. SAHRA reserves the right to cancel this permit by notice to the permit holder.
- 10. This permit is subject to a general appeal and may be suspended should an appeal against the decisions be received by SAHRA within 14 days from the date of the permit. SAHRA may not be held responsible for any costs or losses incurred in the event of the suspension or retraction of this permit.
