PERMIT

Issued under Section 35(4) of the National Heritage Resources Act, Act No. 25 of 1999. Permission is hereby given:

- to: Mr J Hollmann (ID: 6206185035083),
- of: 645 Krige Street, Silverton, 0184,
- for: the surveying and recording of rock markings on the five hills which entails drilling holes in rock at rock engraving sites in order to set up surveying markers,
- at: Gestoptefontein I, at approximately 26° 44' 15.2"S, 25° 59' 50.1"E, Driekuil 2, at approximately 26° 46' 07.9"S, Driekuil 3, at approximately 26°45' 37.2"S, 26° 01' 13.4"E, Driekuil 4, at approximately 26° 46' 29.8"S, 26° 02' 32.1"E and Driekuil5, approximately at 26° 46' 27.1"S, 26° 02' 26.6"E,
- on: the farm Gestoptefontein 349 IO, near Ottosdal,
- in: the Lichtenburg District, North-West Province.

The following conditions apply:

- 1. As few holes should be drilled into the rock as possible to conserve the cultural landscape. No holes should be drilled into rocks with engravings on. Holes should not be drilled into rock adjacent to rocks with engravings unless these holes are >50cm from the engraving.
- 2. If the permit holder is not to be present on the site at all times then SAHRA must be provided with the names and qualifications of the authorised representatives.
- 3. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be used. A full photographic record of the affected surfaces must be made before and after drilling and use of the survey markers.
- 4. A standard site record form must be lodged with the National Cultural History Museum.
- 5. A progress report must be submitted to SAHRA on or before 1 November 2007 and a final report is due on or before 1 November 2008. SAHRA reserves the right to withhold further permits if progress is not deemed satisfactory.
- 6. Reprints of all published papers, or copies of theses or reports resulting from this work must be lodged with SAHRA.
- 7. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
- 8. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
- 9. It is the responsibility of the permit holder to protect sites to during and after work on site to the satisfaction of SAHRA and the landowner.
- 10. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
- 11. SAHRA reserves the right to cancel this permit by notice to the permit holder.
- 12. This permit is subject to a general appeal and may be suspended should an appeal against the decisions be received by SAHRA within 14 days from the date of the permit. SAHRA may not be held responsible for any costs or losses incurred in the event of the suspension or retraction of this permit.
