PERMIT

Issued under Section 35(4) of the National Heritage Resources Act, Act No. 25 of 1999. Permission is hereby given:

- to: Mr N Kruger (ID: 7904035029087) and Dr MH Schoeman as Principal Investigator (ID: 702050221083),
- of: Archaic HPM, Department of Anthropology and Archaeology, University of Pretoria, Pretoria, 0002,
- for: a continuation of excavations (as Phase 2), following Phase 1 exploratory excavations under SAHRA Permit No.80/06/09/007/51, to locate archaeological features at the Old Fort. The first but not only areas to be affected will be:
 - Gun emplacements on the North East, South East and South West corners.
 - The staircase leading up to the South West gun emplacement.
 - The original level and surface finish of the ramparts.
 - Areas where sandbag / clay brick walls may have been originally built and where remains of stone `structures' are now evident (largely on the South and East rampart).
 - Areas where erosion has occurred and where structures / remains have been uncovered.
 - Staircase to the North East Bastion
- at: Old Fort, Constitution Hill, at approximately 29° 11' 20"S, 28° 02' 30"E,
- on: the C/O Joubert & Kotze Streets, Braamfontein, Johannesburg CBD,
- in: the Johannesburg District, Gauteng Province.

The following conditions apply:

- 1. If the permit holder is not to be present on the site at all times then SAHRA must be provided with the names and qualifications of the authorised representatives.
- 2. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be used. Note that the position of all excavations must be marked on a plan of each site.
- 3. A standard site record form must be lodged with the National Cultural History Museum.
- 5. A report on activities connected with this permit must be submitted to SAHRA on or before 1 May 2008 and a final report is due on or before 1 May 2009. SAHRA reserves the right to withhold further permits if progress is not deemed satisfactory.
- 6. Reprints of all published papers, or copies of theses or reports resulting from this work must be lodged with SAHRA.
- 7. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
- 8. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
- 9. It is the responsibility of the permit holder to fill in excavations and protect sites during and after excavation to the satisfaction of SAHRA and the landowner.

- 10. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
- 11. SAHRA reserves the right to cancel this permit by notice to the permit holder.
- 12. This permit is subject to a general appeal and may be suspended should an appeal against the decisions be received by SAHRA within 14 days from the date of the permit. SAHRA may not be held responsible for any costs or losses incurred in the event of the suspension or retraction of this permit.
