For temporary export of five (5) sedimentary samples from Knysna Eastern Heads Cave 1 (KEH1)

The permit is issued to Dr. Thalassa Matthews (Iziko Museums of Cape Town), on behalf of Dr. Naomi Cleghorn (University of Texas at Arlington) and Dr. Ximena Villagram (Universidade de Sao Paulo, Brazil), to temporarily export five (5) sediment samples from KEH1 for thin sectioning at SCT Micromorfologia i Anàlisi d'Imatges, Universitat de Lleida, Spain and micromorphological analysis at Universidade de Sao Paulo, Brazil. The material is currently housed at the Mossel Bay Archaeology Project CRM, Inc., Diaz Museum, Mossel Bay.

Conditions:

1. Only the selected representatives of the material stored in the collection may be exported.
2. The material must be carefully packed and all packaging must be clearly marked with the name of the site (if known), and the name and address of the permit holder or the Diaz Museum, Mossel Bay.
3. The material will be shipped by FedEx to SCT Micromorfologia i Anàlisi d'Imatges, Universitat de Lleida, Spain to prepare thin sections, which will be shipped by FedEx to Dr. Ximena Villagram at Universidade de Sao Paulo, Brazil, for analysis, and to the Diaz Museum in South Africa.
4. Dr. N. Cleghorn is responsible for the transport to Universitat de Lledia, Spain. Dr. Judith Graus Collado is responsible for the preparation of the material in Spain and the transport to Universidade de Sao Paulo, Brazil. Dr. X. Villagram is responsible for the analysis of the material in Brazil and its transport to South Africa before the expiry date of the permit **31 January 2018**.
