1. Ten crew members will be on site during filming.
2. Monitoring and supervision will be done by Lindsey Smith (Assistant Director, Management Authority, Cradle of Humankind) and Lindsay Marshall (Maropeng, Cradle of Humankind).
3. Filming will take place in the standard tourism route through the caves.
4. Filming equipment will consist of: 2 DSLR cameras with lenses; 2 monopods & detachable tracking; 2 GoPro Cameras; sound system & mixer, boom mic & wireless microphone; batteries, chargers, tapes and hard disks.
5. Filming will take place on 22 May 2017.
6. The amount of traffic, i.e. numbers of people on site, should be minimised as much as possible to avoid excessive disturbance of the site.
7. Copies of the filming resulting from this work must be lodged with SAHRA on or before the 31 May 2018.
