Site: Bolt's Farm, Klinkert's portion (Bolt's Farm, Klinkert's portion)

For excavation at Brad Pit A (SW corner); Brad Pit B (E and S corners); Waypoint 160 (main entrance, remove dump); Milo A (W side); Milo B (N side) andBridge Cave (exposed material of the "Panthera spot" of the "Panthera infill") as well as continued preparation of the backlog from X-Cave and maintenance of Femur Dump site on the Klinkert's portion of Bolt's Farm, Sterkfontein 173 IQ (portion 32) within the Cradle of Humankind World Heritage Site.

Conditions:

1. This permit is issued to Dr. Dominique Gommery (CR2P/UMR 7207, Université Pierre et Marie Curie, Paris, France) in collaboration with Dr. James Brink (Florisbad Quaternary Research Department, National Museum, Bloemfontein) and Mr. Lazarus Kgasi (Plio-Pleistocene Palaeontology Section, Ditsong National Museum of Natural History).

2. If the permit holder is not to be present on the site at all times then SAHRA must be provided with the names and qualifications of the authorised representatives.

3. Excavation activities will include sampling and analysis thereof. The site map must be updated regularly and a total station must be used to record the finds.

4. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be employed. Note that the position of all excavations and objects collected must be marked on a plan of the site. Material must be bagged and labelled as per the Ditsong Museum's curation policy.

5. A standard site record form must be lodged with the Ditsong National Museum of Natural History.

6. All material collected and excavated, as well as field notes and records, will be curated by the Ditsong National Museum of Natural History, who will be responsible for the permanent curation and safekeeping of all artefactual material in a condition that allows ongoing research.

7. All sites must be suitably covered when no excavation takes place to avoid erosion and destabilisation of breccias and deposits, in particular during the rainy season (October - April).

• A budget must be kept for maintenance and closure of the site.

8. Annual permit reports on the results of the excavations and analyses must be submitted to SAHRA via email on or before 31 December 2018 and 2019, and a final permit report on or before 31 December 2020. SAHRA reserves the right to withhold further permits if progress is not deemed satisfactory. Permit reports can be made available to researchers on request within three years of the lapsing of this permit.

9. Reprints of all published papers or copies of theses and/or reports resulting from this work must be lodged with SAHRA.

10. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and the excavator is responsible for ensuring that he or she has an understanding with the landowner concerning: the number of visitors and workers; conditions for camping on the property; speed limits on access roads; possible prohibitions on off-road driving; size, type and number of vehicles permitted; possible prohibitions on trespassing beyond the site; disturbing fauna, flora or substrate; erection and demolition of structures on the site; appropriate hours of visiting and working on the site; use of firewood, electricity and water; lighting fires and the prevention of uncontrolled fires and any fencing necessary to protect livestock. Conditions of access imposed by the landowner must be observed.

11. The permitted excavator shall be responsible for the activities and impacts of all colleagues, students and employees under his or her supervision.

12. Excavators must take measures to ensure the safety of any person who may enter the excavation site as part of their excavation team or as their visitor.

13. It is the responsibility of the permit holder to protect sites during and after excavation and to ensure that, where appropriate, excavations are filled in or stabilised with adequate materials (e.g. Loffelstein blocks or army bags in geotextile) to the satisfaction of SAHRA and the landowner.
