**Permit for continued archaeological research and inclusion of Louisa Hutten (University of Cape Town (UCT)) as a collaborator and Field Director at three (3) sites (Witberg 1, Klipbak East Pan, & Kudu Pan) situated in the Tswala Kalahari Reserve, Northern Cape.**

### **Conditions:**

1. This permit is issued to Dr Benjamin Schoville (research affiliate, UCT) in collaboration with Dr Jayne Wilkens, Ms Louisa Hutten (UCT) and Dr David Morris (McGregor Museum, Kimberley)
2. If the permit holder is not to be present on the site at all times then the heritage authority must be provided with the names and qualifications of the authorised representatives.
3. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be employed. Note that the position of all excavations and objects collected must be marked on a plan of site.
4. A standard site record form must be lodged with the McGregor Museum.
5. All archaeological material collected and excavated, as well as field notes and records, will be curated by the McGregor Museum, Kimberley.
6. An annual progress report on the results of the excavations and analyses must be submitted to the heritage authority issuing this permit on 30 April 2022, and 30 April 2023, and a final report is due on or before 30 April 2024.
7. Reprints of all published papers or copies of theses and/or reports resulting from this work must be lodged with the heritage authority.
8. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
9. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
