The permit is issued to Dr Gerrit Dusseldorp (University of Johannesburg), in collaboration with Dr Andrew Carr (University of Leicester, UK), to permanently export 31 (thirty-one) sediment samples from Umhlatuzana Rock Shelter in KZN for stable isotope analysis, lipid extraction and analysis at the School of Geology, Geography and Environment, University of Leicester, UK. The material is currently housed at the KwaZulu-Natal Museum, Pietermaritzburg.

Conditions:

1. Only the selected representatives of the material stored in the collection may be exported.

3. The material will be couriered via DHL to the School of Geology, Geography and Environment, University of Leicester, UK.
4. Dr Andrew Carr is responsible for the analysis of the material and Dr Gerrit Dusseldorp for its transport to the above mentioned institution.
5. The samples must be used for study purposes only, and may not be sold or exchanged.
6. The material may not be loaned to any person or institution other than the above stated participants in the study, without the consent of SAHRA.
7. Destructive analysis or sampling may be undertaken.
8. A report on the activities undertaken in terms of this permit must be lodged with SAHRA before 30
