8. Terms of the Loan Agreement may not be changed after the permit is issued without the consent of SAHRA.
9. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit;
10. Any appeal against this decision must be submitted in writing to SAHRA within 14 calendar days of the issuing of this permit;
11. Should an appeal be lodged against the issue of this permit, the works must be returned to South Africa at the expense of the applicant or relevant third party;
12. SAHRA reserves the right to cancel this permit by notice to the permit holder

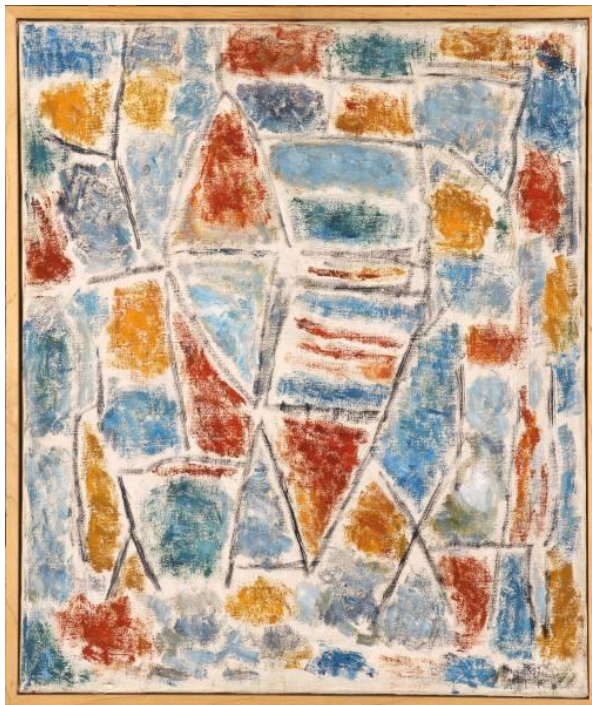
