2 That the work is supervised by the relevant architect and carried out by contractors and artisans experienced in heritage work;

3 That, in the event of any contemplated deviation from the approved plans – including the transfer of the work to the supervision of another architect/technologist –a <u>written motivation</u> in support of the deviations must be submitted to Amafa-aKwaZulu-Natali for consideration and the <u>prior written approval</u> of Amafa aKwaZulu-Natali must be obtained, before any deviations are carried out;

4 In the case of the demolition of a structure/s or part thereof, such demolition must take place <u>not more</u> <u>than 30 days</u> prior to the commencement of the new work, unless otherwise agreed to, in writing, by Amafa aKwaZulu-Natali;

5 Any salvageable items not required for re-use in the project must be offered to the Amafa Conservation Materials Bank and all salvageable elements identified must be delivered to the Amafa Conservation Materials Bank, Pietermaritzburg, at the Applicant's cost.

6 Where <u>archaeological material or human remains</u> are uncovered during excavation, Amafa aKwaZulu-Natali must be contacted immediately in order to determine the significance of the find and mitigation required (a professional archaeologist may need to be employed).
