**PERMIT**

No. 80/05/09/005/51

Issued in terms of the legislative requirements of Section 36(3) of the National Heritage Resources Act, Act No. 25 of 1999. Permission is hereby given:

to: Ms M Patrick (ID: 5201270732083),  
of: the 19 Dawlish Road, Plumstead, Cape Town, 7800,  
for: test pits to be excavated through the floor of the building proposed for demolition and for continued monitoring of all earth moving activities on site in order to assess the likelihood of burials and human remains on the site,  
at: 108-110 Vos Street, on the erven 687 and 688,  
in: the Cape Town District, Western Cape Province.

The following conditions apply:

1. Should any human remains be uncovered all activities on the site must cease and SAHRA must be notified immediately.
2. Please note that this burials permit does not cover issues relating to the built environment, which, where applicable, will require separate approval.
3. All earth moving is to be monitored on site in order to assess the likelihood of burials and human remains on site.
4. If the permit holder is not to be present on the site at these times then SAHRA must be provided with the names and qualifications of the authorised representatives.
5. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be used. Note that the position of the grave must be marked on a plan of the site, and the site marked on a 1:50 000 map.
6. A standard site record form must be lodged with the IZIKO: South African Museum.
7. Human remains must at all times be handled with respect and graves should not be disturbed except where unavoidable. The consultation procedures as indicated in the gazetted regulations of the National Heritage Resources Act (Act No. 25 of 1999) must be observed as appropriate. The recommendations for removal of graves and exhumations and for re-burial made in SAHRA's Policy 'What to do when graves are uncovered', section 3, must be observed as far as possible.
8. Copies field notes and records must be kept at the IZIKO: South African Museum.
9. A report on the excavation must be submitted to SAHRA on or before 1 October 2006.
10. Reprints of all published papers, or copies of theses or reports resulting from this work must be lodged with the relevant Provincial Heritage Resources Authority and SAHRA.
11. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
12. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
13. It is the responsibility of the permit holder to fill in excavations and protect sites during and after excavation to the satisfaction of the SAHRA and the landowner.
14. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
15. SAHRA reserves the right to cancel this permit by notice to the permit holder.

This permit is valid until 1 October 2006.
