The permit is issued to Prof Chris Henshilwood (Evolutionary Studies Institute, University of the Witwatersrand), on behalf of Dr Matthias Meyer (Max Planck Institute for Evolutionary Anthropology), permanently export 24 sediment samples (max 1 gram each) from Klipdrift Cave, Klipdrift Shelter and Blombos Cave, Western Cape Province, for DNA analysis at the Max-Planck Institut, Leipzig, Germany. The material is currently housed at the Iziko Museum of South Africa in Cape Town.

Conditions:

1. Only the selected representatives of the material stored in the collection may be exported.
2. The material must be carefully packed and all packaging must be clearly marked with the name of the site (if known), and the name and address of the permit holder or the Iziko Museum of South Africa in Cape Town.
3. The material will be couriered via DHL to Max-Planck Institut, Leipzig, Germany.
4. Dr Matthias Meyer is responsible for the analysis of the material and its transport to the above mentioned institutions/collections.
5. The samples must be used for study purposes only, and may not be sold or exchanged.
6. The material may not be loaned to any person or institution other than the above stated participants in the study, without the consent of SAHRA.
7. Destructive analysis or sampling may be undertaken.
