4. The material must be hand carried or sent via a reputable professional courier service unless written instructions to the contrary have been received from the repository.
5. The material shall be returned to South Africa on or before 17 March 2021 at the expense of the party referred to in the Loan Agreement.
6. SAHRA must be notified in writing of the return of the material, and a report on the activities undertaken in terms of this permit must be lodged with SAHRA before 17 April 2021.
7. Copies of all papers or publications resulting from this permit must be lodged with SAHRA.
8. Terms of the Loan Agreement may not be changed after the permit is issued without the consent of SAHRA.
9. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit;
