8. SAHRA must be notified in writing of the return of the material, and a report on the activities undertaken in terms of this permit must be lodged with SAHRA before 14 May 2021.
9. Copies of all papers or publications resulting from this permit must be lodged with SAHRA.
10. Terms of the Loan Agreement may not be changed after the permit is issued without the consent of SAHRA.
