The permit is issued to Prof Jonah Choiniere (Evolutionary Studies Institute, University of the Witwatersrand), to temporarily export 21 specimens of the gomphodont cynodonts genera *Massetognathus*, *Diademodon*, *Trirachodon*, *Procynosuchus*, and *Scalenodontoides* for synchrotron scanning at the *European Synchrotron Radiation Facility (ESRF)* facility in Grenoble, France. The material is currently accessioned by the Evolutionary Studies Institute, University of the Witwatersrand.

Conditions:

1. Only the selected representatives of the material stored in the collection may be exported.
2. The material must be carefully packed and all packaging must be clearly marked with the name of the site (if known), and the name and address of the permit holder or the Evolutionary Studies Institute (ESI), University of the Witwatersrand.
3. The material will be hand-carried by Dr Kudakwashe Jakata to the ESRF, and returned to the ESI by Prof Jonah Choiniere.
4. Prof Jonah Choiniere is responsible for the analysis of the material and its transport to and from the above mentioned institutions/collections.
5. The specimens must be used for study purposes only, and may not be sold or exchanged.
6. The material may not be loaned to any person or institution other than the above stated participants in the study, without the consent of SAHRA.
