This permit is issued to Dr Juan Marcos Jannello (Department of Biological Sciences, University of Cape Town), in collaboration with Prof Anusuya Chinsamy-Turan (Department of Biological Sciences, University of Cape Town), for thin-sectioning of 20 specimens of giraffid tooth samples of *Sivatherium hendeyi* and *Giraffa jumae* from Langebaanweg, West Coast Fossil Park National Heritage Site. Specimens were selected due to their already fragmented nature. The material is accessioned by the Iziko Museums of South Africa.

Conditions:

1. As the sampling will reduce the structural integrity, suitable records (measurements and photographs or casts) must be taken prior to sampling.
2. No paratype material may be sampled.
3. Sampling and analysis will take place at Department of Biological Sciences, University of Cape Town.
