- 8. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit may be made available to researchers on request.

- 11. The permitted excavator shall be responsible for the activities and impacts of all colleagues, students and employees under his or her supervision and for their compliance.
- 12. Excavators must take measures to ensure the safety of any person who may enter the site as part of their excavation team or as their visitor.

It is the responsibility of the permit holder or collaborator to protect sites during and after excavation and to ensure that where appropriate excavations are filled in or stabilised with adequate materials (e.g. Loffelstein blocks or army bags in geotextile) to the satisfaction of SAHRA and the landowner.
