The applicant proposes to establish an abalone holding and processing facility on Stateland, near Kleinzee in the Northern Cape Province 5 test pits, up to 1m deep, will be excavated/shovel tested across Site 8221. Test excavations will determine the presence/absence, and significance of sub-surface archaeological deposits. Archaeological observations recorded on Site 8221 comprised dispersed fragments of shellfish (mostly limpets (S. argenvillei and some C. granatina) on a level piece of relatively undisturbed land in the north eastern portion of site (proposed divers guarters). Two pieces of quartz was noted, but no pottery or ostrich eggshell was found. The estimated age of the site is not older than 2000BP. Density of surface remains suggests low significance, but will be confirmed by shovel testing. The action is to determine the depth, significance and extent of sub-surface archaeological deposits, to inform whether full mitigation in advance of development is required. Deposits will be sieved using a 3mm mesh sieve to check for shellfish densities and cultural remains. Shellfish will be used to determine site significance. We will use a method to determine significance designed by Smith and Mutti (2009). All sorting will be done on site and no subsistence or cultural remains will be removed from the property. The positions of all the test holes will be recorded using a hand-held GPS device set on the WGS 84 datum. The stratigraphy of each test pit will be measured and described.
