This permit is issued to Dr Jennifer Botha-Brink (National Museum, Bloemfontein) for invasive sampling of six (6) limb bones of four therapsid species (*Kannemeyeria*, *Robertia*, *Cistecephalus* and *Pristerodon*) from the Karoo for osteohistological analysis at the National Museum, Bloemfontein. The material is currently housed at the Evolutionary Studies Institute, University of the Witwatersrand.

Conditions:

1. As the sampling will reduce the structural integrity, suitable records (measurements and photographs) must be taken prior to sampling.
2. No paratype material may be sampled.
3. Sampling and analysis will take place at the National Museum, Bloemfontein.
