The permit is issued to Ms Sarena Govender (Iziko Museums of South Africa), on behalf of Dr Marco Pavia (Dipartimento di Scienze della Terra, Torino University, Italy), to temporarily export 53 bones of fossil birds from West Coast Fossil Park National Heritage Site for non-destructive morphological analysis at the Dipartimento di Scienze della Terra, Torino University, Italy. Conditions:

5. The fossils must be used for study purposes only, and may not be sold or exchanged.
6. The material may not be loaned to any person or institution other than the above stated participants in the study, without the consent of SAHRA.
7. No destructive analysis or sampling may be undertaken.
