## PERMIT: Export (Temporary)

The permit is issued to Prof Jonah Choiniere and Ms Chande Montgomery (Evolutionary Studies Institute, University of the Witwatersrand) to temporarily export five coprolite specimens from the Early Triassic of Driefontein Farm 11, Free State Province, for non-destructive scanning at the European Synchrotron Radiation Facility (ESRF) in Grenoble, France. The material is currently housed at the Evolutionary Studies Institute.

### Conditions:

1. Only the selected representatives of the material stored in the collection may be exported.
2. The material must be carefully packed and all packaging must be clearly marked with the name of the site (if known), and the name and address of the permit holder or the Evolutionary Studies Institute.
3. The material will be hand-carried to the ESRF by Dr Kathleen Dollman on 12 January 2022 and returned by graduate student Mr Andy Weiss at the end of July 2022.
4. Dr Kathleen Dollman is responsible for the analysis of the material and its transport to the above mentioned institutions/collections. Mr Andy Weiss is responsible for its transport from the ESRF.
5. The samples must be used for study purposes only, and may not be sold or exchanged.
6. The material may not be loaned to any person or institution other than the above stated participants in the study, without the consent of SAHRA.
7. No destructive analysis or sampling may be undertaken.
