The permit is issued to Dr Anna Magrieta van Wyk (University of Pretoria) to sample thirty (30) teeth of fossil wildebeest *Connochaetes gnou* from the site Heelbo on the farm Spion Kop 932, and permanently export the samples for genome re-sequencing analysis at Novogene, Cambridge, UK. The material is currently housed at the National Museum Bloemfontein.

Conditions:

1. Only the selected representatives of the material stored in the collection may be exported.
2. The material must be carefully packed and all packaging must be clearly marked with the name of the site (if known), and the name and address of the permit holder or the National Museum Bloemfontein.
3. The samples will be couriered to Novogene in Cambridge, UK.
4. Dr Anna Magrieta van Wyk is responsible for the analysis of the material and its transport the above mentioned institutions/collections.
5. The samples must be used for study purposes only, and may not be sold or exchanged.
6. The material may not be loaned to any person or institution other than the above stated participants in the study, without the consent of SAHRA.
7. Destructive analysis or sampling may be undertaken. Unused or leftover samples must be returned to the accessioning institution.
