PERMIT

Issued under Section 35(4) of the National Heritage Resources Act, Act No. 25 of 1999. Permission is hereby given:

- to: Dr C K Brain,
- of: 38 King Street, Irene, 0062,
- to: co-ordinate further excavations and investigation of a multi-disciplinary team of researchers, who will be undertaking various projects, which thus far includes rescue of loose blocks of material from the hanging remnant, as well as investigations of fossiliferous fissures infills adjacent to the main cave and excavation of Member 4 sediments exposed during the earlier Brain excavations,
- at: Swartkrans,
- in: the Krugersdorp District, Gauteng Province.

The following conditions apply:

- 1. If the permit holder is not to be present on the site at all times then SAHRA must be provided with the names and qualifications of the authorised representatives.
- 2. The permit holder is required to supply the additional information requested in the accompanying letter.
- 3. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be used. Note that the position of all excavations must be marked on a plan of each site.
- 4. A standard site record form must be lodged with the National Cultural History Museum.
- 5. All material collected and excavated, as well as field notes and records, will be curated by the University of Witwatersrand's Institute of Human Evolution.
- 6. A progress report must be submitted to SAHRA on or before 1 March 2006 and 1 March 2007 and a final report is due on or before 1 March 2008. This should be undertaken by the respective scientists undertaking the various projects at Swartkrans. SAHRA reserves the right to withhold further permits if progress is not deemed satisfactory.
- 7. Reprints of all published papers, or copies of theses or reports resulting from this work must be lodged with SAHRA.
- 8. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
- 9. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
- 10. It is the responsibility of the permit holder to fill in excavations and protect sites during and after excavation to the satisfaction of SAHRA and the landowner.
- 11. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
- 12. SAHRA reserves the right to cancel this permit by notice to the permit holder.

This permit is valid until 1 March 2008.
