- 6. Annual permit reports on the results of the excavations and analyses must be emailed to apmpermitreports@sahra.org.za on or before 31 March 2024 and 2025, and a final permit report on or before 31 March 2026 using the template in the following link: https://sahris.sahra.org.za/content/apmpermitreports. SAHRA reserves the right to withhold further permits if progress is not deemed satisfactory. Permit reports can be made available to researchers on request within three years of the lapsing of this permit.

- 7. Reprints of all published papers or copies of theses and/or reports resulting from this work must be lodged with SAHRA.
- 8.
