**The permit is issued to Prof Jonah Choiniere (University of the Witwatersrand), in collaboration with Dr Celina Suarez (Department of Geosciences, University of Arkansas), to sample 56 specimens of Karoo vertebrates and permanently export the samples for stable isotope analysis at the University of Arkansas, Fayetteville, USA. 5. The samples must be used for study purposes only, and may not be sold or exchanged.
6. The material may not be loaned to any person or institution other than the above stated participants in the study, without the consent of SAHRA.
7. Destructive analysis or sampling may be undertaken.
