The permit is issued to Dr Roger Smith (Iziko Museum), on behalf of Dr Pinhiero and Dr Cisneros (both Universidade Federal do Pampa, Brazil), to temporarily export procolophonid skull SAM-PK-K11292 from the Katberg Formation for CT scanning and morphological analysis at the Universidade Federal do Pampa, Brazil. The material is currently housed at Iziko Museum.

Conditions:

2. The material must be carefully packed and all packaging must be clearly marked with the name of the site (if known), and the name and address of the permit holder or the Iziko Museum.

4. Dr Cisneros is responsible for its transport to the above mentioned institutions/collections, and Dr Pinhiero is responsible for the analysis of the material and its transport from the above mentioned institutions/collections.
5. The skull must be used for study purposes only, and may not be sold or exchanged.
6. The material may not be loaned to any person or institution other than the above stated participants in the study, without the consent of SAHRA.
7. No destructive analysis or sampling may be undertaken.
