**Object:** Schroda canine remains, Diamant canine remains, Kasteelberg canine remains

The permit is issued to Dr Annie Antonites (Ditsong National Museum of Natural History), in collaboration with Prof Andrew Smith (UCT), Dr Luc Janssens (Leiden University), Dr Samantha Brown (Tübingen University) and Dr Pontus Skoglund (Francis Crick Institute), to sample seven (7) faunal remains from Diamant, Limpopo Province; and twenty-five (25) faunal remains from Schroda, Limpopo Province, and temporarily export the above samples as well as twelve (12) samples from Kasteelberg, Western Cape Province, for aDNA analysis at the Ancient Genomics Laboratory at the Francis Crick Institute, London, and ZooMS analysis at the Archaeo and Palaeoproteomics Laboratory, University of Tübingen, Germany. It is noted that the Kasteelberg material is accessioned at Iziko Museums of SA, Diamant material at the Museum of Anthropology and Archaeology at UNISA, and Schroda material at Ditsong Museums of SA.

### Conditions:

1. Only the selected representatives of the material stored in the collection may be exported.
2. The material must be carefully packed and all packaging must be clearly marked with the name of the site (if known), and the name and address of the permit holder or the curating institution.
3. The material will be couriered to the Francis Crick Institute, London, and University of Tübingen, Germany.
4. Dr Annie R Antonites is responsible for the analysis of the material and its transport to and from the above mentioned institutions/collections.
5. The samples must be used for study purposes only, and may not be sold or exchanged.
6. The material may not be loaned to any person or institution other than the above stated participants in the
