**The permit is issued to Dr Gideon de Jager (University of Pretoria) to temporarily export 265 bovid teeth and bone from Boomplaas Cave, Die Kelders Cave, Elands Bay Cave, Klasies River Mouth Caves, Nelson Bay Cave, and Byneskranskop 1 for DNA analysis at the Globe Institute, University of Copenhagen, Denmark. The material is currently housed at the Iziko Museums of South Africa.**

### **Conditions:**

1. Only the selected representatives of the material stored in the collection may be exported.
2. The material must be carefully packed and all packaging must be clearly marked with the name of the site (if known), and the name and address of the permit holder or the Iziko Museum.
3. The material will be couriered to the Globe Institute, University of Copenhagen, Denmark.
4. Dr Gideon de Jager is responsible for the analysis of the material and its transport to and from the above mentioned institutions/collections.
5. The samples must be used for study purposes only, and may not be sold or exchanged.
6. The material may not be loaned to any person or institution other than the above stated participants in the study, without the consent of SAHRA.
7. Destructive analysis or sampling may be undertaken.
