For assessing of material from the dumps from Central Debris Pile, Grey Breccia Dump, Main Quarry Depository and Cone Mouth Depository and sediment sampling at the localities 'Classic Section' (Member 3 Grey Breccia) and Cone Mouth Rear Section (CMRS) at Makapan Limeworks, Makapansgat Valley World Heritage Site, Limpopo Province.

Conditions:

- 1. This permit is issued to Dr Dominic Stratford (University of the Witwatersrand) in collaboration with Dr Jean-Baptiste Fourvel (CNRS, Université Bordeaux, France).
- 2. If the permit holder is not to be present on the site at all times then SAHRA must be provided with the names and qualifications of the authorised representatives.
- 3. Prior to any sampling activities, the site manager must be met on site and must give consent to the extent to which specific areas within the selected localities at Makapan Limeworks will be sampled.
- 4. Activities will include assessing of dumps and sample collection for dating (20x20 cm) and sieving of sediments. A site map must be created and a total station must be used to record the finds.
- 5. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be employed. Note that the position of all sampling and objects collected must be marked on a plan of the site. Materials will be bagged per quadrant or core and labeled carefully.
- 6. A standard site record form must be lodged with the Evolutionary Studies Institute.
- 7. All material collected and excavated, as well as field notes and records, will be curated by the Evolutionary

Studies Institute, who will be responsible for the permanent curation and safekeeping of all artefactual material in a condition that allows ongoing research.

- 8. Annual permit reports on the results of the excavations and analyses must be emailed to apmpermitreports@sahra.org.za on or before 31 May 2024 and 2025, and a final permit report on or before 31 May 2026 using the template in the following link: https://sahris.sahra.org.za/content/apmpermitreports. SAHRA reserves the right to withhold further permits if progress is not deemed satisfactory. Permit reports can be made available to researchers on request within three years of the lapsing of this permit.
- 9. Reprints of all published papers or copies of theses and/or reports resulting from this work must be lodged with SAHRA.
- 10. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and the excavator is responsible for ensuring that he or she has an understanding with the landowner concerning: the number of visitors and workers; conditions for camping on the property; speed limits on access roads; possible prohibitions on off-road driving; size, type and number of vehicles permitted; possible prohibitions on trespassing beyond the site; disturbing fauna, flora or substrate; erection and demolition of structures on the site; appropriate hours of visiting and working on the site; use of firewood, electricity and water; lighting fires and the prevention of uncontrolled fires and any fencing necessary to protect livestock. Conditions of access imposed by the landowner must be observed.
- 11. The permitted excavator shall be responsible for the activities and impacts of all colleagues, students and employees under his or her supervision.
- 12. Excavators must take measures to ensure the safety of any person who may enter the excavation site as part of their excavation team or as their visitor.
- 13. It is the responsibility of the permit holder to protect sites during and after excavation and to ensure that, where appropriate, excavations are filled in or stabilised with adequate materials (e.g. Loffelstein blocks or army bags in geotextile) to the satisfaction of SAHRA and the landowner.
- 14. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
- 15. SAHRA reserves the right to cancel this permit by notice to the permit holder.
