Issued under the KwaZulu Natal Amafa and Research Institute Act No. 05 of 2018.

Approval is hereby given to Henk Steyn of PGS Heritage (Pty) Ltd of Box 32542 Totiusdal, 0134 in accordance with the application received on 07/10/2019, for the relocation of seven(07) unknown graves that will be affected by Ikwezi Mining - Kliprand Farm 8627 HT, Dannhauser Local Municipality, Amajuba District Municipality, KwaZulu-Natal Province. The seven graves will be relocated to an area identified on the remainder of Kliprand Farm 8627 HT, Dannhauser Local Municipality, Amajuba District Municipality, KwaZulu-Natal Province. DESCRIPTION AND LOCATION OF THE GRAVES: The seven(07) graves are deemed to be older than 60 years old as determined by PGS Heritage and fall under the KwaZulu Natal Amafa And Research Institute Act (Act 05, 2018) and the Heritage Resources Act (Act 25 of 1999).The graves are located in informal areas on the farm Kliprand 8627 HT and will be affected by future mining activities: • Grave No. 55: Unknown grave at GPS Coordinates -27.87776°; 30.12457°, • Grave No. 56: Unknown grave at GPS Coordinates -27.87609°; 30.12145° • Grave No. 57: Unknown grave at GPS Coordinates -27.87552°; 30.12140°, • Grave No. 60: Unknown grave at GPS Coordinates -27.87182°; 30.12544°, • Grave No. 63: Unknown grave at GPS Coordinates -27.87034°; 30.12532°, • Grave No. 65: Unknown grave at GPS Coordinates -27.87131°; 30.12236°, • Grave No. 66: Unknown grave at GPS Coordinates -27.87725°; 30.12145°. Some graves in this area have been determined as being more than 60 years while most have been buried in the 1980's to 1990's. However, various methods were implemented to locate the next-of-kin of these seven graves without success. A visual investigation of the graves concluded that the graves are not looked after or visited. Given the above information the seven unknown graves are considered to be older than 60 years and therefore fall under the regulations of the National Heritage Resources Act (Act 25 of 1999) and the parameters of the KwaZulu Natal Amafa and Research Institute Act (Act 05 of 2019).

Site specific conditions:


- The graves should be clearly marked as unknown from location x .Ledgers bearing information on each grave should be placed on each grave.
- The Institute should be furnished with detailed / full documentation highlighting the following:
 - a. The graves original /current and reburial position(location name, gps coordinates etc)
 - b. Full description of grave including contents, dressing , measurements and Photographs before , during exhumation and reburial
 - c. Scaled drawings/survey diagram/map of the burial ground before and after

Conditions: *This permit is issued subject to the following conditions:-*

- 1.1 *That the permit is issued strictly for the purpose/s as set out in the application;*
- 1.2 *That in the event of any contemplated deviation the prior written approval of KwaZulu Natal Amafa and Research Institute must be obtained;*
- 1.3 *In such event, a written motivation in support of such deviation must be submitted to KwaZulu Natal Amafa and Research Institute for consideration and;*
- 1.4 *No deviation will be permitted without the prior written approval of KwaZulu Natal Amafa and Research Institute.*
- 1.5 *Where applicable, KwaZulu Natal Amafa and Research Institute shall have the right to inspect the site at any time;*
- 1.6 *Monthly reports are to be submitted to KwaZulu Natal Amafa and Research Institute on the work being conducted and the findings;*

- 1.7 Monthly reports are to be accompanied by the relevant National Site Record forms;
- 1.8 A final report on the work conducted and the findings must be submitted to KwaZulu Natal Amafa and Research Institute not later than thirty three (33) days from the date of expiration of this permit, extensions are negotiable;
- 1.9 Copies of any papers compiled or published as a result of the work conducted or the findings made must be provided to KwaZulu Natal Amafa and Research Institute;
- 1.10 KwaZulu Natal Amafa and Research Institute shall not be liable for any loss, damage or injuries to any person/s or property caused by any of the activities conducted by the Applicant;
- 1.11 Where artefacts located at the site are, in terms of this permit, exported for research or other purposes, same must be returned immediately upon completion of the research or other activity to KwaZulu Natal Amafa and Research Institute.
- 1.12 All archaeological and paleontological Material become, on discovery, the property of the Province of KwaZulu Natal and must be lodged at the repository of KwaZulu Natal Amafa and Research Institute.
- 1.13 It is the responsibility of the Applicant to ensure that artefacts are preserved in its original state while in his/her possession;
- 1.14 The Applicant shall be liable for any damage or destruction caused at any site or to any artefact.
- 1.15 **FAILURE TO COMPLY WITH THESE CONDITIONS WILL RENDER ANY ACTIVITY CONDUCTED UNLAWFUL, AND KWAZULU NATAL AMAFA AND RESEARCH INSTITUTE RESERVES THE RIGHT TO CANCEL THIS PERMIT AND TO INSTITUTE CRIMINAL AND/OR CIVIL ACTION AGAINST THE PERSON/S RESPONSIBLE.**
- 1.16 The issuing of this permit does not exempt the Applicant from compliance with any other law, where applicable.
