- 2. If the objects must be transported, they must be hand carried or sent via a reputable professional courier service unless an alternative arrangement has been made in writing with SAHRA.
- 3. The objects may not be loaned to any person or institution other than Mr L Bunch and the Smithsonian Institution on behalf of its National Museum of African American History and Culture (NMAAHC) without the consent of SAHRA.
- 4. Should the permit holder wish to apply for an extension of this permit, this intention must be communicated to SAHRA sixty (60) calendar days before the expiry of this permit. The condition reports referred to in 8 below, together with an up-to-date loan agreement referred to in 9, must be uploaded to the case (ID: 9598) on the South African Heritage Resources Information System (SAHRIS) for the application to be processed.
- 5. The material must be returned to South Africa on or before 2 July 2026 at the expense of Mr L Bunch and the Smithsonian Institution on behalf of its NMAAHC, unless extension of the permit is approved by SAHRA.
- 6. SAHRA must be notified in writing of the return of the material and a report on the activities undertaken in terms of this permit must be lodged with SAHRA before 2 July 2026.
