The permit is issued to Mr Gavin Whitelaw (KwaZulu-Natal Museum, Pietermaritzburg), on behalf of Dr Gregor Bader (Senckenberg Centre for Human Evolution and Palaeoenvironment, Tübingen, Germany), to permanently export six sediment samples from Holley Shelter, KZN, for micromorphological analysis at the Senckenberg Centre for Human Evolution and Palaeoenvironment in Tübingen, Germany.
