PERMIT

No. 80/05/07/010/51

Issued under Section 35(4) of the National Heritage Resources Act, Act No. 25 of 1999. Permission is hereby given:

to: Dr Z Henderson (ID: 6407240052085),
of: the National Museum, P O Box 266, Bloemfontein, 9300,
for: (1) the collection of archaeological Middle Stone Age material and a possible rock engraving; (2) detailed mapping, exploration with metal detectors and collection of material in the extended South African war component, with testing and excavation as necessary and particularly excavation of the rubbish dump;
(3) A separate application permit is required for the destruction of the Anglo Boer War wall. This permit will only be considered after the Free State Heritage committee has commented on this. It will also require mapping.
(4) The graveyard is protected. If it is to be conserved, a heritage management plan must be drawn up. Relocation would require a separate burial application and the required public participation process. This permit can only be considered after consultation with the SAHRA Burials Unit,
on: the farm Lilyvale 2313 (subdivision 7, remainder and portion of subdivision 25),
at: approximately 29 04 128S, 26 12 724E,
in: the Mangaung District, Free State Province.

The following conditions apply:

1. If the permit holder is not to be present on the site at all times then SAHRA must be provided with the names and qualifications of the authorised representatives.
2. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be used. Note that the position of all excavations must be marked on a plan of each site.
3. A standard site record form must be lodged with the National Museum.
4. All archaeological material collected and excavated (excluding the burials), as well as field notes and records, will be curated by the National Museum.
5. A Management Plan for the protection of the burials identified at Lilyvale should be in place should the decision be made not to relocate the burials. Human remains must at all times be handled with respect and graves should not be disturbed except where unavoidable. The consultation procedures as indicated in the gazetted regulations of the National Heritage Resources Act (25 of 1999) must be observed as appropriate. The recommendations for removal of graves and exhumations and for reburial made in SAHRA's Policy 'What to do when graves are uncovered', must be observed as far as possible. Should descendants be identified after relocation has already taken place, their wishes should be accommodated in as far as relocating the burials.
6. A report must be submitted to SAHRA on or before 1 September 2006. SAHRA reserves the right to withhold further permits if progress is not deemed satisfactory.
7. Reprints of all published papers, or copies of theses or reports resulting from this work must be lodged with SAHRA.
8. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
9. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
10. It is the responsibility of the permit holder to fill in excavations and protect sites during and after excavation to the satisfaction of SAHRA and the landowner.
11. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
12. SAHRA reserves the right to cancel this permit by notice to the permit holder.

This permit is valid until 1 September 2006.
