PERMIT

Issued under Section 35(4) of the National Heritage Resources Act, Act No. 25 of 1999. Permission is hereby given:

to: Dr U Kusel (ID: 4408205087084),
of: PO Box 652, Magalieskruin, Pretoria, 0150,
for: rescue excavations to retrieve archaeological material from late Iron Age settlement sites that will be impacted by mining development,
at: Malokong Hill,
on: the farms Vriesland 781LR and Vliegkraal 783 LR,
in: the Mokopane District, Limpopo Province.

The following conditions apply:

1. If the permit holder is not to be present on the site at all times then SAHRA must be provided with the names and qualifications of the authorised representatives.
2. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be used. Note that the position of all excavations must be marked on a plan of each site.
3. Consultation with the Mabusela clan and other affected parties should be conducted prior to any mitigatory measures commencing at any of the site. Before the relocation of the grave identified in the Heritage Impact Assessment (March 2005) is undertaken, consultation with the affected community (Mabusela clan) should be undertaken to determine place of reinterment. Graves are protected in terms of the National Heritage Resources Act (No. 25 of 1999) and appropriate procedures for the relocation of graves should be followed as per the requirements of the Act.
4. Areas not affected by the development should be conserved and a management plan for the conservation of these sites established, of which SAHRA must approve.
5. A standard site record form must be lodged with the National Cultural History Museum.
6. All material collected and excavated, as well as field notes and records, will be curated by the National Cultural History Museum.
7. A report must be submitted to SAHRA on or before 1 August 2006. SAHRA reserves the right to withhold further permits if progress is not deemed satisfactory.
8. Reprints of all published papers, or copies of theses or reports resulting from this work must be lodged with SAHRA.
9. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
10. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
11. It is the responsibility of the permit holder to fill in excavations and protect sites during and after excavation to the satisfaction of SAHRA and the landowner.
12. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
13. SAHRA reserves the right to cancel this permit by notice to the permit holder.

This permit is valid until 1 August 2006.
