The permit is issued to Dr Michael Toffolo (CENIEH) and Dr Lloyd Rossouw (National Museum Bloemfontein), to permanently export sediment samples from Lombards Drift Horse Camp spring site near Soutpan, Free State Province, for OSM analysis at the CENIEH in Burgos, Spain; MS analysis at Archéosciences Bordeaux in Pessac, France; and biomarker analysis at Kiel University, Germany.

Conditions:

1. Only the selected representatives of the material stored in the collection may be exported.

3. The material will be hand-carried by Dr. Felipe Cuartero (CENIEH) to the CENIEH. The respective samples will then be hand-carried to Archéosciences Bordeaux by Dr. Maïlys Richard or shipped to Dr Michaela Ecker at Kiel University.
4. The above individuals are responsible for the transport to the above mentioned institutions and the respective analysis.
5. The samples must be used for study purposes only, and may not be sold or exchanged.
6. The material may not be loaned to any person or institution other than the above stated participants in the study, without the consent of SAHRA.
7. Destructive analysis or sampling may be undertaken.
