Issued under Section 35(4) of the National Heritage Resources Act, Act No. 25 of 1999. Permission is hereby given:

- to: Dr WC Nienaber (ID: 6911175094087),
- of: Department of Anatomy, School of medicine, Faculty of health Sciences, University of Pretoria, PO Box 2034, Pretoria, 0001,
- for: rehabilitation and stabilization of old excavation trenches and erosion damage, as well as maintenance and improvements on stabilization measures and tourism infrastructure work at Mapungubwe, K2, Schroda and Little Muck,
- in: the Mapungubwe Cultural Landscape,
- on: the farms Greefswald 35MS, Greefswald 37 MS, Schroda 46 Ms and Little Muck,
- in: the Soutpansberg District, Limpopo Province.

The following conditions apply (Please also read the accompanying letter to this permit):

- 1. Vehicles transporting workers to the sites must stay on designated roads and paths to avoid damage to surface material.
- 2. If the permit holder is not to be present on the site at all times then SAHRA must be provided with the names and qualifications of the authorised representatives.
- 3. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be used. Note that the position of all excavations must be marked on a plan of each site.
- 4. A standard site record form must be lodged with the Polokwane Museum.
- 5. Cultural material recovered and copies of field notes and records will be curated by SANParks subject to SAHRA receiving satisfactory information as requested in accompanying letter.
- 6. A report must be submitted to SAHRA on or before 1 February 2007 that incorporates appropriate references to all phases of rehabilitation thus far. SAHRA reserves the right to withhold further permits if progress is not deemed satisfactory.
- 7. Reprints of all published papers, or copies of theses or reports resulting from this work must be lodged with SAHRA.
- 8. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
- 9. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
- 10. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
- 11. SAHRA reserves the right to cancel this permit by notice to the permit holder.
