Repair damaged box gutters, and waterproof correctly. Repair damaged flat roofs, and waterproof correctly. Install new soaker and stepped flashings on tiled roofs. Replace damaged and missing flashing on sheet metal roofs. Repair tiled roof ridge caps. Repair turret & dormer roof structures, including flashings and roof covering. Repair/ replace gutters and downpipes. Repair roof eaves and barge boards. Waterproof the protruding wall canopies/ mouldings. Install new hail guards over box gutters Where possible it will be done as a like for like basis, using existing materials and fixings when permissible.
