For export of the following objects: 1 ostrich shell fragment 015-K17 (from site HBK2014/015) and 5 shell fragments: 022-L63 (from site HBK2014/022), 034-C4 (from site HBK2014/034), 015-T24 (from HBK2014/015), BRM-K7 CFS 163 (from site Bobartia Road Midden), BRM-M8 SRS3 43 (from site Bobartia Road Midden).

This permit refers to fragments of 1 ostrich eggshell and 5 shells collected at 4 different sites of the southern Namaqualand (HBK) and Betty's Bay (Bobartia Road Midden), Western Cape. Collection and sampling for dating of the material was requested and permitted by Heritage Western Cape. The material will be destroyed during analysis.

The permit is issued to Dr Jayson Orton, ASHA Consulting (Pty) Ltd, in collaboration with Dr Ugo Zoppi, DirectAMS, to export six objects of shellfish and ostrich shell for dating at the facility DirectAMS in Bothell, Washington.

Conditions:

1. Only the selected representative of the material may be exported.
2. The material must be carefully packed and all packaging must be clearly marked with the name of the site (if known), and the name and address of the permit holder or ASHA Consulting (Pty) Ltd.
3. The material will be couriered by Postnet.
4. Drs J. Orton and U. Zoppi are responsible for the analysis of the material and its transport to the above mentioned institution.
5. The samples must be kept for study purposes only, and may not be sold or exchanged.
6. The material may not be loaned to any person or institution other than the above stated participants in the study, without the consent of SAHRA.
