The permit is issued to Prof Anusuya Chinsamy-Turan, Department of Biological Sciences, University of Cape Town, in collaboration with Jordi Estefa Lopez and Sophie Sanchez, both Evolutionary Biology Centre, Uppsala University, Sweden, to temporarily export 15 skeletal elements of vertebrates from various localities in the Karoo for non-destructive Synchrotron scanning at the European Synchrotron Radiation Facility, Grenoble, France in June 2016. The specimens are currently hosted by the Iziko South African Museum, Cape Town.

Conditions:

1. Only the selected representatives of the material stored in the collection may be exported. The bulk of the material remains in the collections of the ESI, Wits.
2. The material must be carefully packed and all packaging must be clearly marked with the name of the site (if known), and the name and address of the permit holder or the respective Museum, in which it is accessioned.
