This permit is issued to Dr. Jayson Orton [ASHA Consulting (Pty) Ltd] for the demolition of poorly preserved historic stone wall sections (sites KSW2 & KSW3) on the farm Standvastigheid 210/Remainder, Sutherland Magisterial District, Northern Cape Province, which will be affected by road construction for the proposed Karusa Wind Energy Facility between Matjiesfontein and Sutherland. Dr. Orton will be monitoring the site while demolition of the stone wall is undertaken on site.

Conditions:

1. If Dr. Jayson Orton is not to be present on the site at all times, then SAHRA must be provided with the names and qualifications of the authorised representatives.
2. Monitoring of the site by Dr. Jayson Orton, or a representative approved by SAHRA, is compulsory for the entire duration of the demolition work undertaken.
3. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be employed. The position of all stones removed must be marked on a plan of site.
4. The stones removed from the wall may be stored on site.
5. A final report on the results of the demolition must be submitted to SAHRA by the end of July 2017.
6. Reprints of all published papers or copies of theses and/or reports resulting from this work must be lodged with SAHRA.
7. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
8. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
9. SAHRA reserves the right to cancel this permit by notice to the permit holder.
