For temporary export of the following nine specimens of *Papio angusticeps* from Haasgat:

HGD 627 (partial mandible), HGD 683 (complete tooth), HGD 632 (partial maxilla), HGD 1244 (complete tooth), HGD 648 (complete tooth), HGD 637 (complete tooth), HGD 619 (partial mandible), HGD 633 (partial mandible) and HGD 615 (partial mandible)

The permit is issued to Mr. Kholisile Nzolo (Curator, Council for Geoscience), on behalf of Dr Justin Adams (Department of Anatomy and Developmental Biology, Monash University, Melbourne, Australia,) to temporarily export 9 fossil teeth or partial jaws of *Papio angusticeps* from the site within the Cradle of Humankind World Heritage Site for stable isotope (carbon & oxygen), trace element and electron-spin resonance (ESR) analysis at South Cross University, Australia. The material is currently housed at Council for Geoscience, Pretoria. The permit will expire in September 2017.

Conditions:

1. Only the selected representatives of the material stored in the collection may be exported.
2. The material must be carefully packed and all packaging must be clearly marked with the name of the site (if known), and the name and address of the permit holder or the Council for Geoscience.
3. The material will be hand-carried to the Department of Anatomy and Developmental Biology, Monash University and the Department of GeoSciences, Southern Cross University by Dr Justin Adams. Residuals will be hand-carried back by Dr Justin Adams. He will be responsible for the transport to and from the above mentioned institutions/collections.
