- 1. This permit is issued to Dr Anton Pelser.
- 2. If the permit holder is not to be present on the site at all times then SAHRA must be provided with the names and qualifications of the authorised representatives.
- 3. Mitigation methods include measuring of excavation blocks, photographing, mapping and detailed description of archaeological features within each block. Grids must be established, preferentially of one meter squares over the site. Excavation of the archaeological material within the grid squares should include scraping off and sieving the surface to collect surface artefact scatters; subsurface testing will check for any deeper deposits. Should deeper material be found these levels should also be sampled over a wider area. Excavated material will be bagged according to the accessioning museum's standard. Mapping will be done using theodolites and GPS.
- 4. An adequate map of the sites must be created and provided to SAHRA.
- 5. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National

Heritage Resources Act must be employed. Note that the position of all excavations and objects collected must be marked on a plan of the site.

- 6. A standard site record form must be lodged with the Lydenburg Museum.
- 7. All material collected and excavated, as well as field notes and records, will be curated by the Lydenburg Museum, who will be responsible for the permanent curation and safekeeping of all artefactual material in a condition that allows ongoing research.
- 8. A final report on the results of the mitigation and analyses must be submitted to SAHRA permit on or before 30 September 2017. SAHRA reserves the right to withhold further permits if progress is not deemed satisfactory.
- 9. Reprints of all published papers or copies of theses and/or reports resulting from this work must be lodged with SAHRA.
- 10. The final permit report can be made available to researchers on request within three years of the lapsing of this permit.
- 11. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and the excavator is responsible for ensuring that he or she has an understanding with the landowner concerning: the number of visitors and workers; conditions for camping on the property; speed limits on access roads; possible prohibitions on off-road driving; size, type and number of vehicles permitted; possible prohibitions on trespassing beyond the site; disturbing fauna, flora or substrate; erection and demolition of structures on the site; appropriate hours of visiting and working on the site; use of firewood, electricity and water; lighting fires and the prevention of uncontrolled fires and any fencing necessary to protect livestock.
