The permit is issued to Dr. Rose Prevec (Albany Museum, Grahamstown) on behalf of Jonah Choiniere (Evolutionary Studies Institute "ESI", University of the Witwatersrand "Wits"), in collaboration with Dr. Vincent Fernandez (European Synchrotron Radiation Facility "ESRF"), to temporarily export an almost complete skeleton of the dinosaur *Nqwebasaurus thwazi* for synchrotron analysis at the ESRF, Grenoble, France. The material is officially housed at the Albany Museum, Grahamstown.

Conditions:

1. Only the selected representative of the material stored in the collection may be exported.
2. The material must be carefully packed and all packaging must be clearly marked with the name of the site (if known), and the name and address of the permit holder or the Albany Museum, Grahamstown.

4. Dr. Vincent Fernandez is responsible for the analysis of the material.
5. Dr. Jonah Choiniere is responsible for its transport to and from the above mentioned institution.
6. The specimen must be used for study purposes only, and may not be sold or exchanged.
7. The material may not be loaned to any person or institution other than the above stated participants in the
