3. The material must be hand carried or sent via a reputable professional courier service unless written instructions to the contrary have been received from the repository, the National Museum of Bloemfontein.
4. The material may not be loaned to any person or institution other than Prof. Jorg Frobisch without the consent of SAHRA.
5. The material shall be returned to South Africa on or before 20 June 2015 at the expense of Prof. Jorg Frobisch.
6. SAHRA must be notified in writing of the return of the material, and a report on the activities undertaken in terms of this permit must be lodged with SAHRA before 20 June 2015.
7. Copies of all papers or publications resulting from this permit must be lodged with SAHRA.
8. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
9. SAHRA reserves the right to cancel this permit by notice to the permit holder.
