PERMIT

Issued under Section 35(4) of the National Heritage Resources Act, Act No. 25 of 1999. Permission is hereby given:

- to: Dr D Curnoe (Passport: E1002062),
- of: the Department of Anatomy, School of Medical Sciences, Faculty of Medicine, University of New South Wales, Sydney, 2052, Australia, in association with Karen van Ryneveld of the McGregor Museum, Kimberley, Northern Cape,
- for: continuation of survey work and to allow for the excavation of up to 2 square metres of brecciated material and to allow for superficial collection up to a further 2 square metres,
- at: Groot Kloof (GKB and GKD), at approximately 28 22'11S, 24 10'02 E,
- in: a private conservation area owned by Holcim Pty Ltd (formerly Ulco),
- in: the Barkly West District, Northern Cape Province.

The following conditions apply:

- 1. If a permit holder is not to be present on the site at all times then SAHRA must be provided with the names and qualifications of the authorised representatives.
- 2. A suitable contract must exist between the permit holder and the repository (McGregor Museum) before work commences. National Site Numbers must be obtained from the Museum.
- 3. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be used. Note that the position of all excavations must be marked on a plan of each site.
- 4. A standard site record form must be lodged with the McGregor Museum.
- 5. All material collected and excavated, as well as field notes and records, will be curated by the McGregor Museum.
- 6. A progress report must be submitted to SAHRA on or before 1 July 2006 and 1 July 2007 and a final report is due on or before 1 July 2008. SAHRA reserves the right to withhold further permits if progress is not deemed satisfactory.
- 7. Reprints of all published papers, or copies of theses or reports resulting from this work must be lodged with SAHRA.
- 8. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
- 9. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
- 10. It is the responsibility of the permit holder to fill in excavations and protect sites during and after excavation to the satisfaction of SAHRA and the landowner.
- 11. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
- 12. SAHRA reserves the right to cancel this permit by notice to the permit holder.
- This permit is valid until 1 July 2008
