5. Reprints of all published papers or copies of theses and/or reports resulting from this work must be lodged with the Eastern Cape Provincial Heritage Resources Authority.
6. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
7. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
8. The heritage authority shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
9. The heritage authority reserves the right to cancel this permit by notice to the permit holder.
