- 5. A progress report must be submitted to HWC on or before 1 June 2005 and 1 June 2006 and a final report is due on or before 1 June 2007. HWC reserves the right to withhold further permits if progress is not deemed satisfactory.
- 6. Reprints of all published papers, or copies of theses or reports resulting from this work must be lodged with HWC.
- 7. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
- 8. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
- 9. It is the responsibility of the permit holder to fill in excavations and protect sites during and after excavation to the satisfaction of HWC and the landowner.
- 10. HWC shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
- 11. HWC reserves the right to cancel this permit upon notice to the permit holder.
