## **PERMIT: Remove from its original position**

**In terms of Section 36(3) of the National Heritage Resources Act (Act 25 of 1999)**

**Site:** Kalgold Mine Expansion Grave Relocation (KALGOLD Mine Expansion)

PGS has been appointed by Harmony Gold Mining Company Limited's Kalgold Operations, to effect the relocation of 20 graves located within the Kalgold mining operations on the farm Spanover 552 IQ. Of the identified graves, 19 are younger than 60 years, 1 is unknown and therefore assumed to be 60 years old. The graves are currently located inside the proposed expansion area of the A-Zone Pit and will be adversely impacted upon by the proposed expansion of the A-Zone pit.

This permit is allocated for the exhumation and relocation of **1 unknown grave**. Graves younger than 60 years must be permitted by the relevant authorities.

Conditions:

1. If the permit holder is not to be present on the site at all times then the heritage authority must be provided with the names and qualifications of the authorised representatives.
2. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be employed. Note that the position of all excavations and objects collected must be marked on a plan of site.
3. A standard site record form must be lodged on SAHRIS.
4. Human remains must at all times be handled with respect and graves should not be disturbed except where unavoidable. The consultation procedures as indicated in the Regulations and the National Heritage Resources Act must be observed as appropriate. The recommendations for removal of graves and exhumations and for re-burial stipulated in SAHRA's Policy 'What to do when graves are uncovered', section 3, must be observed as far as possible.
5. A permit report is due by 30 September 2018.
6. All remains recovered, including relics and artefacts, must be kept with the skeletal material and be reburied at the chosen cemeteries by the next of kin.
