Conditions:

The recommendations for removal of graves and exhumations and for re-burial stipulated in SAHRA's Policy 'What to do when graves are uncovered', section 3, must be observed as far as possible.
- 5. A permit report is due by 31 October 2018. A preliminary report must be submitted within three months from the date this permit is issued.
- 6. All remains recovered, including relics and artefacts, as well as field notes and records, must be kept with the skeletal material and be curated at a local municipal cemetery.
- 7. Reprints of all published papers or copies of theses and/or reports resulting from this work must be
